The Direct Debit Guarantee

- This Guarantee is offered by all Banks and Building Societies that take part in the Direct Debit Scheme. The efficiency and security of the Scheme is monitored and protected by your own Bank or Building Society.
- If the amounts to be paid or the payment dates change Lincoln College Oxford will notify you 10 working days in advance of your account being debited or as otherwise agreed.
- If an error is made by Lincoln College Oxford or your Bank or Building Society, you are guaranteed a full and immediate refund from your branch of the amount paid.
- You can cancel a Direct Debit at any time by writing to your Bank or Building Society. Please also send a copy of your letter to us.

How Gift Aid Helps

If you are a UK taxpayer, signing a Gift Aid Declaration means we can reclaim 25p for every £1 you donate at no further cost to you. If you pay the higher rate of tax, you can reclaim further tax relief on your tax return of the gross donation or, if you so wish, you can allocate the higher rate tax to your gift. Please consider a Gift Aid donation wherever possible.

By signing the Gift Aid declaration, you confirm that you are a UK Income or Capital Gains taxpayer. You also confirm that you have read this statement and want Lincoln College to reclaim tax on your donation. You understand that you must pay an amount of Income Tax and/or Capital Gains Tax in the tax year at least equal to the amount of tax that all the charities and Community Amateur Sports Clubs you donate to, will reclaim on your gifts for the tax year of your donation. You understand that other taxes such as VAT and Council Tax do not qualify. You understand that the charity will reclaim 25p of tax on every £1 that you have given.

Please notify the Development Office if you change your name or address, or if you wish to cancel the declaration. If you are unsure whether your donation qualifies for Gift Aid, we will be pleased to advise you.

Leaving a Legacy
